Charges:

*One Mover and Truck:* \$60.00 per hour

*Additional Movers:* \$25.00 per hour per mover

*Truck Charge:*

- 1) No additional charge inside Columbus and connecting suburbs.
- 2) Outside Columbus area, additional charge based on mileage to and/or from Pataskala and/or the origin. Mileage will be calculated at quote and charged at a rate per mile based on excess miles.

*Start/Finish time:* Hourly rates shall begin when the movers arrive at the origin location and end when the movers have completed all unloading and requested tasks at the final destination. Travel time between the origin and destination is charged at hourly rate. Multiple stops are fine and are charged at the hourly rate between the origin and destination.

*Additional Moving Charges:* No additional charges. Large items such as major appliances or pianos will be moved at the hourly rate. No additional charges for assembly, stairs, disassembly, packing of items or any other requested tasks. Services shall be charged at the hourly rate during the move.

*Moving Supplies:* All moving items such as dollies, moving blankets, straps and carts will be supplied at no charge during the duration of the move.

*Packing Supplies:* Moving boxes can be supplied at \$2.00 per box. Boxes are used, vary in size and can be supplied depending on availability. Shrink wrap can be provided at \$20.00 per roll. Large (55 gallon) plastic bags can be provided at \$10.00 per roll.

*Minimum Charge:* The minimum charge shall be 2 hours.

*Scheduling:* Rates apply to Sunday through Saturday. Holidays and same day service are available at a premium of an additional \$25.00 per hour. Additional charges may be negotiated.

Estimates: Will provide a non-binding estimate of moving costs either in person or over the phone, via text or email depending on the request of the customer. Will provide a copy of a non-binding estimate either at the time of move if phone estimate is accepted or at the time of estimate made in person.

Insurance: Customer will have the option to choose minimal reimbursement at no additional charge or replacement value coverage at an additional cost. This coverage will reimburse the customer up to the replacement value for anything lost or damaged. Additional cost shall be \$10.00 (ten) per \$1000.00 (one thousand) of declared value. Terms and Conditions of the Bill of Lading provides additional information regarding insurance and liability.
